The Infringing Discussion Thread has caused tremendous embarrassment to our client and has adversely affected his reputation and image. The reproduction of the link to the Defamatory Website in the discussion thread and/or reproduction of content thereof constitute actionable defamation, for which our client has the right to take legal actions against you including instituting Court proceedings for an injunction to prohibit your further acts of displaying and/or publishing the Infringing Discussion Thread as well as claiming damages and costs from you.

We hereby demand you to **immediately** remove the abovementioned Infringing Discussion Thread (including its topic and the content thereof) and/or all other unfounded discussion threads and/or articles concerning our client. If we do not receive your satisfactory reply **within the next 7 days**, our client will consider taking all necessary actions against you to protect his legitimate rights.
